#### **Recording Secretary**

- Nine (100%) councils reported that minutes were taken at meetings.
- Seven (64%) councils assisted the president with the compilation of the annual report.
- Six (67%) recording secretaries were a signing officer.
- Five (56%) knew where the council charter is located.
- Five (56%) maintained a list of the executive with their contact information.
- Four (44%) councils reported having a copy of the *Handbook for Secretaries* from national office.
- Three (33%) acknowledged the existence of a council motion book while four (44%) did not have a motion book.
- Two (22%) received written reports from the executive while five (56%) sometimes received them.
- One (11%) council reported the position is vacant.

# **Corresponding Secretary**

- Two (22%) secretaries reported having a copy of the *CWL Personal Letter Writing Guide* from national office.
- One (11%) council reported the position is vacant.

# **Recording Secretary**

Minutes were recorded and reports submitted for:

- Diocesan Annual Meeting of Members/Convention: October 2;
- Advent Retreat: held virtually on November 27.

# **Treasurer's Report**

#### **Annual Report Survey**

Since only 9 of 25 councils completed their reports, this treasurer's report cannot be considered a true picture of the status of the Ottawa Diocesan Council.

- The report was completed by the treasurer of seven (78%) councils and by the secretary-treasurer at two councils (22%).
- Councils reporting used cheque books (100%) bank statements (89%), deposit books (78%), and receipt books (33%) to keep track of receipts and disbursements. Councils used Excel spreadsheets (56%), other computer programs (22%) or manual ledgers (33%) to record transactions to councils.
- The majority of councils charged dues of \$20.00 or \$25.00 yearly.
- All councils (100%) made National Voluntary Funds donations submitted through the national office. All councils (100%) contributed funds to parish activities.
- Councils had three signing officers with two signatures required on cheques.
- Annual budgets were prepared by 78% of councils.
- Financial statements were presented at monthly general meetings by 100% of councils. Reports presented included current balance, monthly debits and credits and upcoming expenses. Council books were examined yearly by only (56%) of councils.

# **Questions Concerning Communications**

In most cases, communications questions were responded to by only five or fewer councils.

- Councils were usually 50%, always 25%, sometimes 25% satisfied by communications received from national.
- Councils were usually 50%, always 25%, sometimes 25% satisfied by communications received from the provincial council.
- Councils were usually 40%, always 40%, sometimes 20% satisfied by communications received from the diocesan council.
- Information received by parish councils from national was relevant usually 50%, sometimes 50% of the time.
- Information received by parish councils from provincial was relevant usually 75%, sometimes 25% of the time.

- Information received by parish councils from the diocesan council was relevant always 40%, usually 40%, sometimes 20% of the time.
- Information received by parish councils from national was considered clear and concise usually 50%, always 25 % sometimes 25% of the time.
- Information received by parish councils from the provincial council was considered clear and concise usually 50%, always 25 % sometimes 25% of the time.
- Information received by parish councils from the diocesan council was considered clear and concise usually 40%, always 40 % sometimes 20% of the time.
- Councils received duplicate information from national, provincial, and diocesan councils occasionally 40%, usually 20%, sometimes 20% and never 20%.
- When councils received communications from another level (national, provincial, diocesan) that invited or requested participation, councils had enough time sometimes 40%, occasionally 40%, usually 20% to do so.

# Statement of Review of the Ottawa Archdiocesan CWL Council 2021 Accounting Records

At the request of the Ottawa Archdiocesan CWL Council Treasurer, I have examined the financial records for the year ending December 31, 2021, and have found them to be in accordance with generally accepted accounting principles. The accounting records are entered using spreadsheets, and are comprised of monthly bank reconciliations, deposits, transfers and paid invoices.

Deposited cheques were properly endorsed or stamped deposit only as required. The bank provides pre-printed cheques. All bank statements, which include Bank deposit slips, ATM deposits and photocopied cheques on both sides, were reconciled on a monthly basis. All void/cancelled cheques were accounted for.

#### **Review of Transactions**

I have reviewed expense transactions for 2021 and supporting documentation was present for each. Expense receipts including travel were generally reasonable, and original receipts were attached to each claim.

In general, prudent financial and administrative practices are in place and executed as required.

# **Past President Report**

2021

Diocese: Ottawa Chairperson: Vacant

Sub-chairperson: none Parishes Reporting: 11/25

#### **Serve in a Consultative Capacity**

- Nine (82%) of eleven councils reported this position was filled.
- Eight councils (89%) felt supported and encouraged by the past president's help.
- Seven past presidents (78%) attended scheduled meetings and events.
- Four (44%) have been called upon for advice.
- Three past presidents (27%) have held this position before.
- Nine presidents (64%) felt supported and encouraged by their past president's help.
- Four past presidents (36%) were called upon for advice monthly.
- Four councils (36%) sought advice from their spiritual advisor.
- Three councils (21%) sought advice from the diocesan executive and the provincial executive.
- Two councils (14%) sought advice from life members in the area.
- Some council past presidents were asked to represent their councils at conventions, organize social events, promote the League in their parishes and communities, check websites at all levels of the League for information to share, chair executive and/or general meetings, to fill the role of vacant standing committee chairs and chair the nominations and elections committee.

# Be Responsible for Archives and History

- Nine councils (82%) knew the location of their council charter.
- Seven past presidents (78%) were responsible for the archives in their councils.
- Five councils (46%) stored their archives in their CWL room, cupboard or filing cabinet at the church. Three councils (27%) stored them in the church hall or in the parish office. One council (9%) appointed a member who stored them in her home.
- Nine councils (82%) kept deceased members' history indefinitely; one council (9%) kept them for one-four years.
- Eight councils (73%) reviewed their archives as needed.
- Eight councils (73%) maintained a history book.
- Eight councils (73%) labelled photo albums and scrapbooks.
- Eight councils (73%) kept records of service pin and award recipients indefinitely; one council (9%) for nine to 10 years.

- Seven councils (64%) stored the Book of Life indefinitely.
- Seven councils (46%) used bankers' boxes and memory sticks to store archived information.
- Seven council (64%) kept minutes of general meeting indefinitely; two councils (18%) for one to four years.
- Seven councils (64%) kept minutes of executive meetings indefinitely; one council (9%) for five-eight years.
- Seven councils (64%) kept years of service for members indefinitely and one council (9%) did not keep that information.
- Six councils (55%) kept financial information indefinitely; one council (9%) kept them for nine-ten years.
- Six councils (55%) kept executive members written reports indefinitely; three councils (27%) for one to four years; and two councils for five to ten years.
- Five councils (46%) kept annual reports indefinitely; one council (9%) kept them for nine-ten years.
- Five councils (46%) kept membership renewal data indefinitely; four councils (36%) for five-eight years.

# Facilitate the Study and Implementation of the Constitution & Bylaws 2013 (revised)

- Nine councils (82%) had a copy of the *Constitution & Bylaws* and three councils (27%) reviewed it twice a year.
- Eight councils (73%) had a copy of the *National Manual of Policy and Procedure*. Two councils (18%) reviewed it twice a year and one council (9%) reviewed it multiple times a year.
- Seven councils (64%) had their own manual of policy and procedure which gets updated every two years.
- Nine past presidents (82%) sought advice from the diocesan council.
- Three councils (27%) sought advice from their spiritual advisor.
- Three councils (27%) rarely sought the advice from the local bishop.
- Two councils (18%) sought the advice from life members in the area on a monthly basis.
- One council (9%) sought advice from the provincial and from the national executive every month.
- One council (9%) asked for advice from the national office monthly.

#### **Diocesan Highlights**

• In December 2018, the diocesan archives were moved to a Dymon Storage facility due to lack of space at the Ottawa Diocesan Centre which is now closed. This expense continued to be in effect in 2021.

# **Organization Report**

#### **Recruit Members and Maintain Membership**

- Eight councils (80%) administered their member renewals online.
- Seven councils (70%) recruited new members by personal invitation.
- Seven councils (70%) presented service pins, and certificates of merit.
- Six councils (67%) recognized their members with cards or announcements.
- Five councils (50%) encouraged a wide cross-section of members to increase the
  cultural and age diversity of the community with the following: advertised in the
  parish bulletin and on bulletin boards; used display tables at parish events, potluck
  dinners, membership teas and other social events for recruitment; presentations
  at masses; gave gift memberships; used social media and telephone trees.
- Five councils (50%) reflected cultural diversity of the general community.
- Three councils (38%) have members under the age of 35 which reflects the age diversity of the general community.
- Some of the new members were invited to participate in sub-committees and conducted an orientation session.
- All new members were engaged by council members with conversation, new member kit, invitations, member feedback and mentoring.
- All new members were welcomed at meetings.

#### **Leadership Development and Resource Material**

- Eight councils (80%) implemented the new Welcome Program for new members.
- Eight councils (80%) were aware of the new *Executive Orientation* to assist parish councils with training parish council executives.
- Eight councils (80%) were current on the latest activities of the Strategic Planning Implementation Committee.
- Five councils (63%) set annual goals and plans that included members' input.
- Five councils (63%) heard of the toolkit, *Embracing Diversity: Tools for Council Use*, published to assist parish councils with welcoming new members.
- Three councils (30%) had members of their council that played a role at the diocesan level of the League. There were no other council members involved at the provincial and national levels.

#### **Annual Reports**

- Eight councils (80%) found the latest version of the annual questionnaire a meaningful way to demonstrate the organization standing committee activity.
- Five organization chairpersons (50%) used guidelines and assisted their executive members in completing their annual reports.

#### **Life Membership**

Six councils (50%) gained assistance from life members living in the area.

# Community Life Standing Committee Report

2021

Sub-chairpersons: none Parishes Reporting: 6/25

## **Dignity and Rights of Persons**

- Three of the six councils that reported had Community Life Chairpersons
- Two councils were familiar with the Universal Declaration of Human Rights
- Regarding support for minority groups:
  - two councils provided a monetary donation to those suffering from homelessness; and
  - o four councils donated to those suffering from poverty.
- With regard to Indigenous peoples:
  - o three councils were aware of the struggles of Indigenous women
- Three chairpersons became aware of the laws and what has been done in the fight against human trafficking.
- One chairperson shared this information with their council members.

#### **Social and Economic Justice**

- Due to COVID-19 restrictions, most councils were unable to provide help and support in this area; council members were encouraged to help, where possible, on an individual basis.
- With regard to caring for those in need:
  - Affordable housing two supported in prayer
  - Anti-poverty one supported financially
  - o Before, during and after school programs one supported in prayer
  - Clothing drives -one supported financially, two volunteered
  - o Drop-in centres two supported in prayer
  - Emergency shelters for the homeless one supported in prayer
  - Emergency shelters for those experiencing domestic abuse one supported in prayer
  - Employment and skills training one supported in prayer
  - Food banks two supported financially
  - Food hampers two supported financially
  - Resource centres for single parents one supported in prayer
  - Restorative justice program one supported in prayer
  - Soup kitchens one supported financially
  - Violence prevention programs one supported in prayer
  - Wish Foundation one supported in prayer.
- Two councils supported organizations geared towards assisting Indigenous

- peoples.
- Two councils celebrated National Indigenous Peoples Day on June 21.
- One council recognized the first National Day for Truth and Reconciliation on September 30.
- Councils were not able to do anything with restorative justice programs or prison ministry due to COVID-19 restrictions.
- One council spoke at meetings to promote Catholic Near East Welfare Association (CNEWA).

#### **Refugees, Immigration and Citizenship**

- With regard to the needs of immigrants and refugees in the community:
  - Availability of employment services two councils rated their understanding as good, three as fair
  - Availability of English language courses one council rated their understanding as good, two as fair
  - Financial assistance for food and rent one council rated their understanding as good, one as fair
  - Countries of origin one council rated their understanding as good, two as fair
  - Number of immigrants and refugees in community one council rated their understanding as good, one as fair.
- Six councils indicated they were able to explain the difference between temporary foreign worker, immigrant and refugee.
- Five councils participated in Remembrance Day services and five supported the Royal Canadian Legion poppy campaign.
- One council wore red on Fridays in support of our Canadian troops.

# **Developing Countries**

- Three councils were aware of the League's program for the Canadian Catholic Organization for Development and Peace (CCODP) of donating 1% of the price of luxury items purchased during the year to CCODP.
- Three councils became somewhat aware of the conditions of child labour in developing countries.
- One council became somewhat aware of the implications of trade laws.
- One council became somewhat knowledgeable about the economic difficulties of developing countries.
- One council somewhat criticized the structures that put profits before people.
- Councils supported the following organizations that focus on developing countries:
   Canadian Red Cross, Chalice, Habitat for Humanity, Pennies for the Poor and Sleeping Children Around the World.

- Four councils (57%) were informed about the quality of Catholic religious instruction in the Catholic schools in their area.
- Three councils became informed about the quality of Catholic religious instructions in their parish and inquired how they could support the program.
- Three councils (33%) investigated the needs of Catholic schools that could be met by their council. These needs included sacramental, faith development, scholarships and bursaries, tutoring and school supplies.
- One council actively encouraged parents to participate in all areas of their children's Catholic school education and activities.
- One council sewed and provided re-usable masks and also collected winter clothing for their school children.
- One council identified the need for sacramental / faith and the need for scholarships and bursaries.

#### **Rites of Christian Initiation**

• Two councils reported that members were personally involved and participated in the Rites of Christian Initiation programs in their parish.

# **Literacy and Continuing Education**

- Two councils (22%) had a current list of Catholic universities or colleges in the diocese and the information was provided.
- There were no councils who encouraged members to assist those wanting to improve their literacy skills.

# **Scholarships and Bursaries**

- Four councils provided or contributed to a bursary for a high school student.
- Four (44%) councils provided a bursary, scholarship or provided funds.
- Four (44%) councils were familiar with the criteria for applying the National Bursary Fund and three councils contributed to the fund.
- Two councils ordered the revised bursary certificate from national office.
- Two councils have a list of scholarships and bursaries that were available.
- One council provided a bursary to Catholic Christian Outreach.

- One council contributed to a scholarship for elementary aged children.
- One council provided a bursary for a university / college student.
- One council provided funds to a Catholic elementary school for Christian Leadership awards.
- One council promoted the National Bursary Fund and brochure.
- One council contributed \$25.00 to the Coady International Institute.

# Wellness and Sickness/Disease

- Councils supported the following national organizations that focus on the health and wellness of Canadians: Canadian Cancer Society and Canadian Red Cross.
- Councils were not aware of the program and therefore did not contribute to the Canadian Blood Services Partners for Life program.
- Councils were not aware of the Partners for Life Program.
- During National Hospice Palliative Care Week, five councils participated in the "12 Hours of Prayer for Palliative Care" by arranging a prayer service in their home; provided members with the "12 Hours of Prayer for Palliative Care" kit and encouraged their members to pray for palliative care.
- Members did not use or were not aware of the Palliative Care postcard.
- One council provided information on advance care planning.
- One council provided information on emergency response information kits.
- A Mental Health Resource list was prepared and shared with members.
- A Zoom presentation on Loneliness and Tools for Coping was arranged for their parish council members and parishioners.
- A monthly Book Club was started for one council members via Zoom.

#### **Environment**

- Five councils (56%) participated in the Care for Our Common Home initiative.
- Due to COVID-19, many councils' environmental plans were put on hold, however, members were committed to eliminating single use water bottles, plastic bags, plastic straws and trying to reduce their garbage. Presentations were made on Zoom on environmental issues including gardening and recycling.
- One council committed to planting a tree to commemorate the 100<sup>th</sup> anniversary of the League and it will be planted at their parish's new location.
- One council celebrated Earth Day by shutting off their lights.

#### **Genetics**

- Five councils (71%) rated their knowledge as poor and two councils (29%) rated their knowledge as good in regards to the advantages and disadvantages of technology to alter genes in light of the teachings of the Catholic Church.
- Three councils wanted more information from the Education & Health Standing Committee Chair specifically related to what is taught in our Catholic schools.

#### Marriage and Family

- All councils (100%) promoted family enrichment programs by donating money to local women's shelters, made referrals to appropriate organizations or offered personal support at the parish level.
- Two councils (25%) supported people who suffered from domestic abuse.
- No councils celebrated or organized events for National Family Week.
- One council (13%) promoted programs and supported happily married couples.
- Events to support marriage and families were limited to prayer and the support of local charities for the donation of personal care items.

#### **Sanctity of Life**

- Eight councils (100%) prayed regularly for the protection of life.
- Three councils (38%) owned a membership in a local pro-life organization.
- Six councils (75%) attended pro-life masses; three councils (38%) participated in the 40 Days for Life and participated in the virtual March for Life event; one council (13%) participated in the Life Chain; two councils (25%) participated in pro-life walks and pro-life vigils.
- Four councils (50%) donated money and gifts to the following organizations that advocate for the sanctity of life: Campaign Life Coalition, Birthright; Pregnancy and Family Support Services and Euthanasia Prevention Coalition.
- Two councils (25%) ensured every member had a copy of the current pro-life brochure available from national office.
- Two councils (25%) had copies of the current pro-life brochure available in their church vestibule.
- Three councils (38%) wrote letters and informed legislators of CWL resolutions on abortion and euthanasia.
- One council (13%) met with pro-life legislators.

#### **Ministry to Youth**

- Two councils (25%) participated in programs for young people in their parish.
- One council (13%) sponsored leadership camps or retreats.
- Youth were also supported with Rosary classes in local elementary schools and bursaries in local high schools.

#### **Ministry to the Disabled**

- All councils (100%) reached out to the disabled by visits, phone calls, prayed together, sent cards, provided transportation, brought communion, and gave gifts on special occasions.
- One council (13%) organized and participated in support groups and respite for caregivers.

#### **Ministry to Seniors**

• Five councils (63%) called and/or visited; three councils (38%) sent cards of encouragement, gifted them memberships and organized social events; two councils (25%) brought communion, initiated social programs and celebrations, involved them in intercessory prayer and involved them in CWL events. One council (13%) provided transportation.

# **Ministry to Widowed**

• Five councils (63%) called or visited; three councils (38%) sent cards of condolence; and two councils (25%) provided prayers and support after the death of the spouse.

# **Ministry to Separated & Divorced**

• All councils (100%) had copies of the new brochure, "Annulments Today – Merciful and Just," which was available in their church vestibules for people who may need this advice.

#### **Vocations**

- Six councils (86%) sent spiritual bouquets.
- Six councils (50%) participated in prayers for vocations.
- One council (14%) encouraged families to invite priests into their home.

# **Communications Report**

#### The Canadian League Magazine

- In the winter 2021 edition, five councils (50%) resonated with the President's Message and the National Spiritual Advisor's words of wisdom.
- Five councils (50%) were drawn to the articles on "Caring for Our Common Home," "Action in the Time of COVID-19," "Call to Meeting," "Are You Crazy," and "The Journey Continues: Implementing the Strategic Plan."
- In the spring 2021 edition, five councils (50%) resonated with the "President's Message" and "Implementing the Strategic Plan: A Legacy of Renewal." Four councils enjoyed "The Many Faces of Leadership," "Handy Hints and What is Truth? a Reflection on Fratelli Tutti."
- In the fall 2021 edition, six councils (60%) identified with the article Honouring the Gift of Service. Four councils (40%) did not read the fall edition of *The Canadian League* magazine.
- When the magazine was mailed, members found it to be a useful resource for education, advocacy, action, a spiritual resource and a source for new ideas.

#### **Media: to Promote the League**

- Nine councils (90%) shared with their members the strategic planning information.
- Eight councils (80%) encouraged members to use cwl.ca for current information.
- Eight councils (80%) shared with their members the League sponsored mass on April 26 in honour of the Feast of Our Lady of Good Counsel.
- Seven councils (70%) promoted faith-oriented programs to their members.
- Seven councils (70%) had a telephone committee to invite members to events.
- Four councils (40%) promoted the National Day for Truth and Reconciliation.
- Three councils (30%) informed their members that the first Sunday in June is World Communications Day.
- Three councils (30%) encouraged members to visit Facebook or Twitter.
- Two councils (20%) encouraged members to subscribe to and promote Catholic newspapers, periodicals and magazines and financially assisted in their mission to evangelize.
- Two councils (20%) urged their council to set aside a budget for publicity.
- One council (10%) used local media to advertise their activities and events.

#### **Media: Evaluation and Promotion of Good Content**

Nine councils (90%) shared with their members the strategic planning information.

• Six council (60%) shared the strategic planning information from *The Canadian League* magazine and also shared the monthly updates on the national website.

#### **Media: Newsletter and Bulletins**

- All councils used email to send out meeting agendas and minutes.
- Five councils (50%) promoted their council's activities and events through the church bulletin, parish websites, newsletters, council designed promotional brochures, council websites, diocesan website and diocesan newsletter.
- Five councils (50%) used the diocesan "CWL Wednesday!" email to promote their fundraisers and events.
- Four councils (40%) produced their own parish council newsletter. The newsletter
  was prepared by the parish council president or the communications chair. The
  newsletter was distributed by email and mailed to members who don't have access
  to a computer.

#### **Media: Relations**

• All councils (100%) reported not having worked with their local media for the benefit of the League as a result of the ongoing pandemic.

#### **Pornography**

- Four councils (40%) took steps to become aware about the influence that pornography has on children and adults.
- Four councils (40%) read newspaper articles.
- Three councils (30%) acted on Resolution 2017.02 Mandatory Age Verification Mechanisms for Adult Pornography Websites, by contacting their members of parliament. These councils made members aware of the lack of age verification controls on adult websites.
- One council (10%) acted on Resolution 2004.11 Link Between Violent, Graphic Imagery and Aggressive Behaviour and the Mechanics of Killing. This council wrote to provincial/territorial government to establish procedures to prohibit the sale and distribution to minors of videos, movies and games that contain graphic imagery which promotes violence and even killing as an acceptable behaviour. The council also ensured that the educational system contains required curricula to provide students with the tools to respond thoughtfully and critically to media content.
- One council (10%) acted on Resolution 2002.11 Responsible Internet Use for Children. The council encouraged the federal government to continue supporting research and development of tools to protect children against offensive content on the internet.
- One council (10%) attended seminars or conferences on the topic of pornography and reviewed current legislation.
- All councils chose not to participate nor distributed the League's Pornography Hurts postcards in 2021.

Members appreciated their weekly email news or phone calls throughout the pandemic. The biggest challenge was not all communications chair were allowed to inform members of all League activities at their president's request, leaving members uninformed.

# **Resolutions Report**

## **Research and Preparation of Resolutions and Briefs**

- Four councils (66%) were passionate about euthanasia and assisted dying.
- Two councils (33%) were passionate about Indigenous issues and palliative care.
- Two councils (33%) contacted their federal government representative by letter writing.
- One council (17%) contacted their local government and wrote letters.
- One council (17%) contacted their provincial government representative by email and wrote letters.
- One council (17%) attended workshops that outline the resolutions process in the League for their own personal development.
- One council (17%) was familiar with the resolution that required action as listed on the cwl.ca, e.g., 2017.01 Protection from Coercion of Conscience for Healthcare Professionals.
- None of the councils began research to develop a resolution in 2021.
- Six councils (100%) attended workshops that outlined the resolutions process in the League:
  - o at a diocesan, provincial, or national convention
  - o at a diocesan or provincial development days or workshops
- Three councils (33%) considered and studied issues that might become resolutions.

#### Study and Implementation of Resolutions adopted by other Levels

- All councils (100%) referred to communiques and annual reports from all levels
  of the League. These were shared among members during the pandemic that
  inspired new ideas.
- Three councils (50%) undertook actions that support resolutions adopted at all levels of the League.
- Two councils (33%) became familiar with the resolutions that require action as listed on the national website, cwl.ca.

The biggest challenge in this standing committee was trying to generate interest.

# **Legislation Report**

2021

Sub-chairperson: none Parishes Reporting: 4/25

#### **Monitor and Study Legislation at All Levels of Government**

- All councils (100%) knew the names of their local, provincial and federal government representatives (municipal, provincial and federal).
- All councils (100%) received mailings from their federal representative.
- All councils (100%) expressed being uninformed.

#### **Preparation of Briefs and Position Papers Proposed Legislation**

• One council (25%) accessed *Hansard*, the printed record of the proceeding of the federal government.

#### Knowledge of Federal Bills:

- Three councils (75%) were very aware of Bill C-7 on medical assistance in dying.
- Two councils (50%) were very aware of Bill C-233 on sex-selective abortion.
- Two councils (50%) were very aware of Bill C-268 on intimidation of health care professionals and one council (25%) had some knowledge of it.
- One council wrote letters at all levels of government regarding Bill C-7 An Act to amend the *Criminal Code* (medical assistance in dying).
- Councils were either not interested or not aware of the Faith in Action workshop that was distributed in the fall of 2021.
- In general, councils shared information at meetings, provided links to relevant websites and addressed local needs.

The biggest challenge for this standing committee is that the chair was predominantly empty in the parish councils. The council presidents felt they had to take on this role and kept their council members informed.

# **Spiritual Development**

2021

Diocese: Ottawa Chairperson: Janet Warren

Sub-chairpersons: None Parishes Reporting: 9/26

• Of nine councils reporting, eight (89%) of the positions were filled.

• Of those filled, 63% were appointed.

#### **Spiritual Growth of Members**

- Care of Our Common Home: six councils (67%) were not engaged due to COVID-19; three (33%) had discussion, sent out prayers and researched information.
- Four councils (44%) spent one third of their meeting time on spiritual aspects of membership; five (56%) did not. Of these five, four (80%) were not given sufficient time and one (20%) did not have meetings due to COVID-19.
- Liturgies and programs were greatly restricted again this year; however, one council (11%) did have an active program despite restrictions. Five (56%) had none due to COVID-19. Three (33%) sent prayer lists or prayers by email.
- Three councils (33%) did not celebrate the Feast of Our Lady of Good Council.
   Three (33%) participated in the diocesan event which included a remembrance of all members who had died in 2019 and 2020. One council (11%) encouraged members to say a Rosary. One council (11%) had a mass and a crowning of Mary. One council (11%) advised members by email of the feast.
- One council (11%) recognized CWL National Faith Day by personal prayer.
- Regarding the attendance at meetings of the Spiritual Advisor: three (33%) always attended; three (33%) sometimes; and three (33%) never. Six councils (67%) included the Spiritual Advisor on their agenda, while three (33%) did not.
- Regarding the role played by the Spiritual Advisor: seven councils (78%) advised that he was very active; e.g., he was always available for guidance and counsel, he kept the council informed about developments in the diocese, he celebrated devotions such as the Stations of the Cross and had messages for the council.
- Chairpersons reported growing spiritually by: four (44%) said a daily rosary; four (44%) prayed novenas; three (33%) did bible study; three (33%) read spiritual books; two (22%) had prayer partners; two (22%) participated in retreats; two (22%) prayed the Divine Mercy Chaplet; and one (11%) prayed the Liturgy of the Hours. None (0%) journaled and five (56%) reported other activities such as watched or attended daily mass, private prayer, consecration to St. Joseph, completed prayer shawls and food bank fundraisers.
- Three councils (33%) found information on the national website.

#### **Role of Women in the Church**

• Seven councils (78%) did not study Catholic teachings and the role of women in the Church, while two (22%) did. One council (11%) studied the Old Testament women of the Bible and promoted readings and websites to search.

- In response to Pope Francis, six councils (67%) prayed a daily rosary to end COVID-19 and three councils (33%) did not.
- Members undertook the following leadership roles in the parish: five (56%) as parish committee chairpersons; four (44%) on parish pastoral council; three (33%) on diocesan council/committees; two (22%) on parish finance committee; one (11%) as a pastoral associate; and four (44%) in other ministries such as Eucharistic Ministers of Holy Communion, ushers and liturgy committee. Three councils (33%) did not participate on liturgy committees.

#### And Evangelization and Mission Assistance

- Regarding support of Catholic Missions in Canada, two councils (22%) did not report; three councils (33%) sent financial support; four councils (44%) did not support due to COVID-19.
- Other missions that were supported included: Campaign Life, St. Joe's Women's Centre, Christian Catholic Outreach, Youville Centre, Northern Ontario Missions with gift cards, backpacks and school supplies for children in need.

#### **Lay Ministries**

- Chairpersons participated: four (44%) in hospitality; four (44%) as lectors; three (33%) in decorating, three (33%) as facilitators; two (22%) in music; one (11%) as a sacristan; and one (11%) as an usher.
- Councils reported that their members participated in ministries: nine (100%) as lectors, seven (78%) decorated, Extraordinary Ministers of Holy Communion, seven (78%), sacristan seven (78%), music five (56%), facilitator three (33%), hospitality three (33%), and usher two (22%).
- The following were chaired by a CWL member: choir five (56%), Extraordinary Ministers of Holy Communion three (33%), hospitality three (33%), decorating two (22%), sacristan two (22%), usher two (22%), lector two (22%), and facilitator one (11%).

#### **Ecumenism and Interfaith Endeavours**

- One council (11%) reached out to women of other Christian denominations in prayer, by invitation to a meeting or social event, or as a speaker.
- One council (11%) promoted Week of Prayer for Christian Unity and 5 councils (56%) promoted World Day of Prayer.

#### **Training and Communication**

- One (11%) attended the Ottawa Diocesan Annual Meeting of Members. Two (22%) welcomed regular communications from the spiritual development Chairperson from all three levels.
- Training requested: three (33%) requested retreat workshops, two (18%) requested guidance for spiritual development chairperson.
- Regular communications were received from the diocesan council to keep members connected and informed.

One council reported the success of their monthly prayer list. One council shared reflections by a CWL member. One reported on the value of the Diocesan Advent Retreat. One reported on the gift of Bishop Barron's YouTube resources.

Compassionate end of life care has one member enlisted in a virtual course to become a "Death Doula" through an organization called, "End of Life Doula Association of Canada."
